ORDINANCE 2017 - _____

Ordinance amending Sections 111.06, 111.11, 111.12, 111.13 and 111.14 of the Codified Ordinances of Loveland and Declaring an Emergency

WHEREAS, Section 111 of the Codified Ordinances of the City of Loveland provides a mechanism for enforcement and the recovery of costs associated with certain permits issued and events held within the City of Loveland (the "City"), and

WHEREAS, the City desires to amend Sections 111.06, 111.11, 111.12, 111.13 and 111.14 to change the fees associated with certain permits and events held within the City of Loveland.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Loveland, Hamilton, Clermont and Warren County, Ohio:

Section 1. Section 111.06 of the Codified Ordinances of Loveland, Ohio shall be amended in its entirety as follows:

111.06 NISBET PARK FEES

The fee for use of Nisbet Park pursuant to Section 955.02(b) shall be \$75.00.

Section 2. Section 111.11 of the Codified Ordinances of Loveland, Ohio shall be amended in its entirety as follows:

111.11 TRANSIENT BUSINESS AND VENDOR'S PERMIT

The fee associated with the issuance of a Transient Business or Transient Vendor's Permit within the City of Loveland shall be \$20.00 for a one day event and \$75.00 for an annual permit.

Section 3. Section 111.12 of the Codified Ordinances of Loveland, Ohio shall be amended in its entirety as follows:

111.12 MOBILE FOOD TRUCK LICENSE

The fee associated with the issuance of a Mobile Food Truck License associated with a special event shall be \$20.00 per day.

Section 4. Section 111.13 of the Codified Ordinances of Loveland, Ohio shall be amended in its entirety as follows:

111.13 OUTDOOR MUSIC AND AMPLIFICATION PERMITS

The fee associated with the issuance of a permit for Outdoor Music and Amplification in the City shall be \$20.00 per event or \$50.00 for an annual permit.

Section 5. Section 111.14 of the Codified Ordinances of Loveland, Ohio shall be amended in its entirety as follows:

111.14 SPECIAL EVENT PERMIT FEES

The fees associated with Special Events held in the City of the Loveland shall be as follows:

- (a) An application fee of \$200.00 shall be required for all Special Events as defined by the City's Special Events Policy.
- (b) Services provided in conjunction with a Special Event shall be provided as needed at the following rate:
 - I. Police Patrolman \$45 per hour
 - II. Police Supervisor \$55 per hour
 - III. Fire/EMS Personnel \$40 per hour
 - IV. Public Works Personnel \$35 per hour

All of the above rates shall be billed at a three (3) hour minimum for the provision of such services.

- (c) The fee for utilization of Nisbet Park shall be \$75.00.
- (d) There shall be a \$50.00 fee for the City installing an electric subpanel for Special Events separate and apart from any fees associated with the consumption of electric for a Special Event.
- (e) Tents that are larger than 10" by 10" used as part of a Special Event shall be subject to Hamilton County's Fee Schedule for such tents.
- (f) There shall be a \$45.00 fee for field inspections for tents used in conjunction with a Special Event.

Section 6. That this legislation is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the City. The reason for such necessity is that this will allow for these fees to go into effect in a timely manner. Therefore, provided this emergency Ordinance receives the affirmative vote of two-thirds of all members elected to Council, this legislation shall take effect and be in force immediately upon its passage; otherwise from and after the earliest period allowed by law.

Section 7. Council hereby finds and determines that all formal actions relative to the passage of this legislation were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
